COMPENDIUM OF GRAND COUNCIL POLICY FROM 25 OCTOBER 1999 TO MAY 2012 ISSUE 8

Introduction

- A significant body of Order policy is created by decisions of the Grand Council for which no "corporate memory" exists other than minutes of the meetings. The Steering Committee has tasked the International Office with maintaining a Compendium of Grand Council policy. It should be emphasised that this Grand Council Policy is in addition to the overarching policy contained in The Order's Statutes and Regulations and numbered Grand Council Instructions (GCIs), details of which are not repeated here.
- 2. The Compendium, which follows, is designed to enable Establishments to research items of extant policy by subject area. The Compendium is updated annually after each Grand Council meeting and reissued to reflect changes of policy as they occur. Entries in the Compendium are divided into 11 Sections as follows:
 - 1. Governance (G)
 - 2. Financial (F)
 - 3. St John Eye Hospital Jerusalem (H)
 - 4. St John Ambulance (A)
 - 5. St John Associations (J)
 - 6. Ceremonial (C)
 - 7. Honours and Awards (HA)
 - 8. St John Logo (L)
 - 9. Alliance/SMOM (S)
 - 10. Unrecognised Orders (O)
 - 11. Global Trading (T)
- 3. Each entry records the policy subject matter and, where applicable, the relevant decision minute of the Grand Council, plus the source document on which the decision was based, if relevant. Several entries will appear to be overlapping. This is deliberate, insofar as it allows researchers to establish the context in which decisions have been made. On some occasions, a decision of an earlier Grand Council has been partially modified by a subsequent one, but with some aspects of the original decision remaining extant; hence it is sometimes necessary to determine the precise policy by reference to decisions of more than one Grand Council meeting.
- 4. Readers will note that entries are on occasion duplicated. Again, this is deliberate, as for example an entry dealing with, say, the relationship

between the Hospital and The Order will be entered under Section 1 – Governance, because it is a fundamental Governance issue, but also under Section 3 - St John Eye Hospital, as it is also a Hospital issue.

5. The International Office is aware that, whilst every effort has been made to ensure thoroughness of entries, it may well be that some aspects of policy have been overlooked. Should readers determine that this is the case, the International Office would be most grateful to be informed so that this can be rectified in subsequent issues. In any event, feedback on any aspect of the Compendium is always welcome.
